# Department of Defense Transactions for Work Performed in Japan 2002-2009: Implications for Guam

December 2010

Guam Economic Development Authority with technical assistance from the Bureau of Statistics and Plans

#### **Report Highlights**

This report is intended to assist Guam businesses in planning for contractual opportunities in the provision of products and services that may result from the relocation of Marines to Guam after initial construction is completed. Report highlights include:

- All DoD service branches obligated an average of \$2 Billion per year for products and services in Japan. This obligation excludes approximately \$3 Billion per year in financial support from the government of Japan provided under the Status of Forces Agreement between Japan and the U. S.
- The Navy and Marine Corps alone obligated 1.2 times more money in Japan per year than all DoD combined obligations in Guam.
- A conservative estimate of \$200 Million per year could be obligated by the Navy and Marines on Guam in addition to the \$400 Million per year already obligated by all DoD components on Guam.
- The Navy and Marine Corps obligated 8 times more money in Japan on services than on products.
- Guam businesses could expect increases in the need for all products with substantial increases in the need to supply pipe, tubing, hose and fittings; plumbing and waste disposal; ship and marine equipment; aircraft and air frame structural components and accessories; mechanical power transmission equipment and rope, cable, chain and fittings.
- Guam businesses could expect increases in the need for all services with substantial increases in the need to provide modification of equipment services; quality control, testing and inspection services; installation of equipment services; medical services; and education and training services.

#### Introduction

The Guam Economic Development Authority (GEDA) is responsible for providing recommendations to eliminate or mitigate adverse economic impacts associated with the Guam buildup. As part of this responsibility, GEDA began looking at the extent to which Guam businesses participate in federal contracting with the objective of ensuring that local businesses obtain as much opportunity as possible to participate in contracts associated with the military buildup. The results of GEDA's analysis are contained in the report entitled "Federal Transactions for Work Performed in Guam" released in September 2009. GEDA believes that local business involvement in federal contracting is a primary method by which the economic benefits of the buildup would be sustainable over the long term.

Since publication of the September 2009 report, Navy has awarded the basic construction contract vehicles for the buildup in the form of Multiple Award Construction Contracts (MACC). The MACCs have been awarded to companies selected through the competitive process and as funding becomes available over the next several years, the Naval Facilities Engineering Command will award task orders for various construction projects off the basic MACCs. Local construction companies are participating in the MACCs as prime contractors, as partners with other companies or as subcontractors.

Now that construction contract vehicles are in place, GEDA is focusing on postconstruction contract opportunities in line with the policy of sustainability through local business participation. In 2008, GEDA requested the Navy to provide information on contracting in Japan. The Naval Facilities Engineering Command Marianas via the Joint Guam Program Office (JGPO) responded "The best answer to what GovGuam would appear to be seeking is that future contract requirements to support the Marines on Guam are likely to be similar in nature to current contracts supporting Naval Base Guam and Andersen AFB." To understand the "nature" of future contract opportunities and to obtain a sense for the "extent" of future contracting, GEDA contacted the Bureau of Statistics and Plans whose staff expertise and technical assistance enabled the downloading of a significant amount of raw data produced by the federal government on federal transactions in Japan via its website www.USAspending.gov. While GEDA analyzed the data and takes full responsibility for the analysis, none of this work could have been accomplished without the professionalism, dedication and diligence of the staff of the Bureau of Statistics and Plans, for which GEDA is extremely grateful.

## **Purpose of the Report**

The purpose of this report is to provide information to local businesses that may assist them in planning for support service contract opportunities that may arise from Marine Relocation once construction has been completed. This report accomplishes this objective by analyzing of 77 categories of products and 26 categories of services procured by the U. S. military in Japan and Okinawa. By accessing historical information for work performed in Japan, local businesses may be able to predict how the relocation of Marines to Guam may increase contracting opportunities with respect to the types of products and services required and the level of military demand for these products and services.

#### **Limitations of the Report**

The data base extracted from the USAspending.gov website reports "transactions" which are distinct from "contracts". One contract may have multiple transactions. The bulk of these transactions are "obligations" but numerous zero dollar and negative dollar entries are included. The former appears to be contract amendments that have no dollar values associated with them while the latter are de-obligations of dollar amounts. Zero and negative dollar transactions are excluded from the detailed analysis in this report.

While it was intended that the report analyze work performed for the U. S. military in Okinawa, the data contained in USAspending.gov did not allow the segregation of Okinawa data for separate analysis. Therefore, the data is analyzed by Navy and Marine Corps contracting office in order to allow prospective businesses to individually determine types and amounts of products and services potentially required by the Marine Corps upon relocation to Guam.

The USAspending.gov website reports U. S. government spending and any monies expended by the government of Japan as part of the Status of Forces Agreement are not included in this analysis. The DoD Inspector General report dated March 12, 2007 states "the Japanese Government contributes approximately \$3 Billion annually for things like labor and utilities." As the Japanese Government would not contribute funding for the products and services required by Marines relocating to Guam, it is assumed that the dollar amounts included in this report constitute an underestimate of procurement requirements when the Marine Corps move to Guam.

Finally, the information in the USAspending website is constantly updated for both current and prior years. Therefore, total dollar transaction amounts presented in this report may not be identical to the total dollar transaction amounts listed in the USAspending.gov website after publication of this report.

Despite these limitations, the USAspending.gov website is highly recommended for anyone wanting to analyze federal contracting. The USAspending.gov website contains federal contracting information for states, territories and foreign areas where federal funds are spent from Fiscal Years 2000 to current. One hundred and thirty (130) fields of information are provided for each federal transaction including dollars transacted, contracting agency, bidding process, awardees, small business participation, compliance with contracting laws, and many other data.

#### U. S. Military Bases in Okinawa and Japan

As mentioned previously, GEDA intended to analyze data concerning product and service transactions performed in Okinawa; however, the data did not allow segregation. As an alternative, certain assumptions are made by analyzing the extent of military population and military bases that exist in Okinawa as a percentage of all military population and bases in all of Japan. As shown in the table below, 48% of the buildings and 46% of the land area used by the U. S. Military in Japan are located in Okinawa.

Although not all of the above bases in Okinawa are Marine Corps bases, it is assumed that 50% of the land and 50% of the buildings are used in support of the Marine Corps in Okinawa for the purposes of this report. The 2009 Defense of Japan report developed by the government of Japan indicates "As of January 2009, about 74 percent in square measure of United States Forces Japan facilities and area nationwide (for their exclusive use) was concentrated in Okinawa." Since this report utilizes 50%, potential contractual opportunities may be understated.

Reliable data regarding active duty military personnel stationed in Japan and Okinawa was more difficult to obtain as indicated in the sources below:

• The U.S. Forces Japan (Commander of all U. S. Forces in Japan) website indicates 37,000 active duty personnel including "about 2,000 Army; 16,000 Marines, 6,000 Navy; and 13,000 Air Force.

- A March/April 2010 Foreign Affairs article entitled "The US-Japan Treaty at 50" by George Packard, Council of Foreign Relations, indicates 44,850 military personnel and 44,289 dependents "with about 75% in Okinawa."
- GlobalSecurity.org states "Okinawa prefecture hosts over half of the U. S. forces in Japan and that about 75% of the land U. S. forces occupy in Japan is on Okinawa." The website also indicates that there are 47,000 U. S. military, 52,000 dependents, 5,500 civilians and 23,000 Japanese workers.
- A February 26, 2007 article in <u>Newsweek</u> entitled "America's Unsinkable Fleet" indicates that there are 1,965 Army, 3,742 Navy, 13,322 Air Force and 14,424 Marines in Japan.


For the purposes of this analysis, it is assumed that half of the U. S. Marine Corps active duty personnel stationed in Okinawa will be assigned to Guam. Since half of the land and half of the buildings in Japan are located in Okinawa and half of the Marines located in Okinawa may relocate to Guam, the report estimates that half of all support service transactions by the Navy and Marines in Japan could likely be transacted in Guam once the Guam buildup is completed.

#### **Total DoD Transactions**

From Fiscal Years 2002 to 2009, all service branches of the Department of Defense (DoD) obligated an average of \$2 Billion per year for work performed in Japan. On the average, 38% (\$783 Million) of the total average dollar amount of transactions is deobligated by the DoD for various reasons. It is reported that de-obligated amounts are usually reprogrammed to other projects so that amounts de-obligated are not considered losses to the economy.



## **Transactions by DoD Components**

From Fiscal Years 2002 to 2009, transactions by Department of Defense for work performed in Japan was led by the Army (38%), then Navy (24%), followed closely by the Air Force (23%), Defense Logistics Agency (13%), Dept. of Defense Educational Activity (0.65%) and all other DoD entities (0.68%). If the Army spike in 2006 is replaced with the Army's average annual transaction, Navy would lead all DoD entities with 36% while Army transactions would drop to 6% of all DoD average annual transactions.

#### **Transactions by Navy/Marine Contracting Offices**

Since the Marine Corps which is part of the Department of the Navy will be relocating to Guam, transactions made specifically by Navy and Marine contracting offices are presented for business planning purposes. The table below depicts the level of contracting by various Navy and Marine Corps contracting offices. Based upon total and average dollar transactions from 2002-2009 (only 2006-2009 are depicted in the table below), the top 10 contracting offices, their missions and their relationship with the Marine Corps are:

- 1. Naval Facilities Engineering Command Far East the single facilities command serving Navy, Marine Corps and other DoD activities in the Far East Region that provides best-value facility solutions and services to Navy and Marine Corps bases at Misawa, Atsugi, Yokosuka, Iwakuni, Sasebo, Okinawa, Diego Garcia, Chinhae Korea, Singapore and elsewhere throughout the Far East.
- 2. Fleet and Industrial Supply Center Yokosuka the Western Pacific region's largest U.S. Navy logistics command which provide logistics support to the Navy, Marine Corps, other Department of Defense (DoD) and federal activities within the 7th Fleet Area of Responsibility.
- 3. Naval Facilities Engineering Command, Far East Yokosuka Detachment same as number 1 above.
- 4. Fleet and Industrial Supply Center, Yokosuka Detachment, Sasebo same as number 2 above
- 5. Marine Base Camp Butler Camp Smedley Butler is a Marine Corps base in Okinawa that is actually a collection of facilities and satellite installations spread throughout Okinawa.
- 6. Military Sealift Command Supports our nation by delivering supplies and conducting specialized missions across the world's oceans.
- 7. Fleet Readiness Center, Atsugi Provides ready-for-tasking (RFT) aircraft and aviation support equipment to U.S. Navy and Marine Corps Pacific Fleet forces, permanently sited in or deployed to Pacific Command (PACOM) and Central Command (CENTCOM) Areas of Responsibility (AOR), by providing cost-wise organic and commercial depot-level rework, modification, and repair of Naval Aviation weapon systems, support equipment, and aeronautical components.
- 8. Naval Air Systems Command, Patuxent River Provides full life-cycle support of naval aviation aircraft, weapons and systems operated by Sailors and Marines including research, design, development, and systems engineering; acquisition; test and evaluation; training facilities and equipment; repair and modification; and in-service engineering and logistics support.
- 9. Naval Facilities Expeditionary Logistics Center, Port Hueneme Provides overarching asset management on behalf of the Navy Expeditionary Combat Command (NECC) and other expeditionary forces and is responsible for lifecycle management of the equipment and materials required to support their missions and provides wartime maintenance and mobilization of NCF equipment, and mobile utilities in support of global Navy and Marine Corps requirements.

10. Naval Sea Systems Command, Washington DC - Develops, delivers and maintains ships and systems on time, on cost for the United States Navy.

#### **Product and Service Transactions**

In this section of the report, tables and charts are presented to provide businesses with historical data on purchases of products and services by the Navy and Marines. The tables and charts are organized by product or service code (PSC) and obligations are presented by contracting office for fiscal years 2002-2009. Products are distinguished by a two-digit numerical code (e.g., PSC "10" – Weapons products) while services are identified by a single letter alpha code (e.g., PSC "V"- Transportation, travel and relocations services).

The USAspending.gov data base also contains more specific data on the type of product or service by using a four-digit PSC and also its corresponding North American Industry Classification System (NAICS) code, examples of which are included in the discussion under the analysis of each two-digit PSC in this report. However, while detailed 4-digit PSC and NAICS information is available at GEDA, it is not presented in this report due to its length. Also, data for fiscal years 2002-2006 are not included in the tables below however the total dollar transactions for each PSC include those years. Should the reader determine that this level of detail is warranted for business planning purposes, it can be made available upon request.

The table below presents the dollar amount of obligations made by the Navy and Marines in Japan.



On the average from 2002-2009, only 13% of the dollars obligated by the Navy and the Marine Corps was used for the purchase of products. Approximately eight times more money was obligated by the Navy and Marine Corps for services than for products.



## **Japan and Guam Transactions**

GEDA's report entitled "Federal Transactions for Work Performed in Guam 2000-2008" included data on all DoD transactions in Guam. The data contained in that report is compared below with Navy and Marine Corps transactions conducted in Japan from 2002 to 2009 in order to present potential business expansion opportunities. Averages are used in recognition that different years are being compared.

Based upon the above data, the Navy and Marines obligated 1.2 times more money in Japan than the amount obligated in Guam by all DoD components. Assuming that only half of the Marines and obligations in their support will be moved to Guam, another \$200 Million per year in additional obligations could occur in addition to the \$400 Million per year average obligations on Guam by all DoD service branches.


